I hereby grant this indemnity in consideration of Lotus Cars Limited ("Lotus") permitting me to drive and/or ride in a Lotus vehicle or my own vehicle either on a track ("Track") or on the public roads ("Road").

I understand that driving or riding in vehicles on a Track/Road involves a degree of risk. I will abide by all rules and procedures applicable to the use of the Track/Road and the reasonable instructions of Lotus' employees and agents (including without limitation not to race any vehicle on the Track/Road).

I understand that Lotus' employees and agents may cancel the driving of and/or riding in vehicles at any time:

- (i) for any reason relating to health and safety; and/or
- (ii) if Lotus considers, in its reasonable opinion, a person appears unfit to drive for medical reasons or due to the influence of alcohol or drugs.

I acknowledge that I drive or ride in the vehicles entirely at my own risk. I hereby waive any claim, which I may have against Lotus arising from my negligence (whether through any of my acts of omissions) or failure to follow Lotus' reasonable instruction or any other rule or procedure whether such failure is due to any third party or me.

I warrant that:

- (i) I hold a full and valid driving licence and that I do not have endorsements or penalties that could disqualify me from driving; and
- (ii) in circumstances where I am using my own vehicle on the Track/Road I have an adequate insurance policy in full force and effect to cover the risks associated with using a vehicle on the Track/Road and that my vehicle is free from mechanical defects.

I understand that Lotus shall at all times remain liable in respect of death or personal injury caused by its negligence.

I hereby agree to indemnify and keep indemnified Lotus in full against:

- (i) any and all liability, costs, expenses, claims, damage or judgments which Lotus suffers whether in respect of a third party or otherwise as a result of my negligence or failure to follow Lotus' reasonable instructions (including any procedures or rules in place); and
- (ii) any and all tolls, congestion charges, parking and road traffic fines incurred whilst I am driving a Lotus vehicle.

I confirm that I do not suffer (and have no history of suffering) from epilepsy, heart conditions or any other medical condition that may affect my ability to drive or ride in any vehicle.

I understand that whilst on Lotus property I may, from time to time, see confidential project or development vehicles or parts of such vehicles ("Confidential Vehicles"). I agree that I will not take any photographs of Confidential Vehicles and shall not discuss the existence of any Confidential Vehicle with any third party.
